Information provided pursuant to art. 13-14 of the GDPR European Regulations 2016/679

The writer Poloplast snc, based in Carbonera (TV) in Via Biban, 37 C.F. and P.I. IT 04189830260, informs you that, for the establishment and execution of contractual relations with you in progress, is in possession of your data, also acquired verbally, directly or through third parties, qualified as personal of the Regulations of the European Union 2016/679 (GDPR). According to the law, this treatment will be marked to the principles of correctness, secularity, transparency of your privacy and your rights.

Pursuant to art. 13 of the GDPR 2016/679, therefore, you are provided with the following information:

Nature of the data processed: Your personal, fiscal and economic data are required for the performance of contractual relationships, in place or in the future, with your company, as well as the achievement of one effective gestione of commercial relations. The data are processed are processed without your express consent (Article 24 letter a, b, and of the Privacy Code and article 6 letter b, and of the GDPR), only for the following Service Purposes: fulfill the pre-contractual, contractual and tax obligations deriving from existing relations with you; fulfill the obligations provided for by law, by a regulation, by community legislation or by an order of the Authority; exercise the rights of the owner, for example the right to defense in court. The writer is not in possession of your qualifying data as particular or of a judicial nature (articles 9 and 10 of the GDPR).

Purpose of the processing and duration: Your data are processed for the duration of the contractual relationship and also subsequently, for contractual requirements and related fulfillment of legal and tax obligations, and for effective management of financial and commercial relationships, operations indicated in art. 4 of the Privacy Code and art. 4 n. 2) GDPR. The owner will process personal data for the time necessary to fulfill the aforementioned purposes and in any case for no longer 10 years from the termination of the relationship for the purposes of service.

Methods of treatment: The treatment will be carried out both with manual and / or computerized and telematic tools with logic of organization and processing strictly related to the purposes themselves and in any case in such a way as to guarantee security, the confidentiality of the data in compliance with the organizational, physical and logical measures provided for by the provisions in force.

Obligation or right to provide data: Regarding the data that we are obliged to know, in order to fulfill the obligations provided for by laws and regulations in force, their failure to provide it implies the impossibility of establishing or to preside the relationship within the limits in which such data are necessary for the execution of the same.

Scope of knowledge of your data: The following categories of subjects may become aware of your data, as managers or processors, appointed by the undersigned company, data controller: managers, administrators, accounting and invoicing staff, marketing agents for products and services, agents and representatives.

Your rights: In your capacity as an interested party, you have the rights set forth in art. 7 of the Privacy Code and art. 15 of the GDPR and precisely:

- 1) To obtain confirmation of the existence or not of personal data concerning you, even if not yet registered, and their nation in intelligible form;
- 2) Obtain the indication: a) of the origin of personal data; b) of the purposes and methods of the processing; c) of the logic applied in case of treatment carried out with the aid of electronic instruments; d) the identification details of the managers and the representative so designated pursuant to art. 5, paragraph 2 of the Privacy Code and art. 3, paragraph 1, GDPR; e) of the subjects or categories of subjects to whom personal data can be communicated or who can learn about it as appointed representative in territory of the State, of managers or agents;
- 3) To obtain: a) updating, rectification or integration of data; b) cancellation, transformation into form anonymous or blocking of data processed in violation of the law, including those that do not need the conversion in relation purposes for which the data were collected or subsequently processed;
- 4) Oppose, in whole or in part: a) for legitimate reasons to the processing of personal data concerning you, even to the treatment of personal data concerning you for the purpose of sending advertising material relevant to the purpose of the collection; b) to the treatment of personal data concerning you for the purpose of sending advertising or direct sales

Where applicable, you will also have the rights referred to in art. 16-21 GDPR (Right of rectification, right to be forgotten, right to limitation of treatment,

right to the portability of data, right of opposition), as well as the right of complaint to the Guarantor. At any time you can

obtain confirmation of the existence or not of personal data concerning you and the communication of such data and the purposes on which it is based

treatment. Furthermore, you can obtain the cancellation, transformation into anonymous form or blocking of data processed in violation of the law,

as well as updating, retraining or, if there is an interest in it, data integration. You can oppose it for reasons

legitimate, to the treatment itself.

We kindly ask you to promptly report to the company's reporting office any changes to your data

personnel so as to be able to comply with art. 11, letter c) of the aforementioned legislation, which requires that the data collected are accurate and,

then updated.
